- 2.E) If any of the articles of these Terms is declared invalid by a court order or by a binding decision of another competent authority, the other provisions of these Terms will remain in effect.

Article 3. Agreements

Article 7. Retention of title

Article 8. Intellectual and industrial property rights

- 8.A) The customer must fully and unconditionally respect all intellectual and industrial property rights that rest on the products supplied by Pure4sports.
